Terms and Conditions

1. Vehicle hire rate for Just Autos loans cars will be \$75 per day inc. gst, any fines/infringement, fuel costs, cleaning costs are not included in the daily rate.

2. Any and all breaches of traffic regulations or parking infringements/fines and toll fines will be reported to Just Auto's and paid promptly by the user of the hire vehicle. In the incidence whereby the customer does not disclose the infringement or fine, Just Autos will advise the issuing department of the infringements/fines (when the infringements/fines are received) of the relevant customer's details and the customer will be responsible to take full responsibility for the infringements/fines as per the law.

3. The user will exercise proper care and diligence for the security of the vehicle and will do nothing to jeopardise any and all insurance claims that may arise while the hire vehicle is in the user's care.

4. The hire vehicle is comprehensively insured by Just Autos with a minimum policy excess of \$700 and up \$2000.00 for driver under the age of 25. In the event of an accident, loss/theft, the user will pay the insurance the implied excess prior to taking their vehicle of which we are repairing.

5. In the event of a claim declination due to the user's fault the user will undertake to reimburse Just Autos any and all costs to reinstate the hire vehicle. The user will be responsible for any and all third party property of vehicle claims made against the user.

6. You agree and acknowledge that:

(a) only You or an Authorised Driver will drive the Vehicle; and

(b) You and any Authorised Driver hold a current and valid licence (not

being a learner's licence or provisional licence) to drive the Vehicle

and have been licensed to drive vehicles of the same category as the

Vehicle for at least 12 consecutive months immediately prior to signing

the Rental Document.

7. The user will allow no other person/s to operate the hire vehicle while it is in their care. Any breaches of this clause will void all insurance cover.

You and any Authorised Driver must:

(a) not use, or allow the Vehicle to be used, for any illegal purpose, race, contest or performance test of any kind;

(b) not carry, or allow the Vehicle to carry, more passengers than may be properly accommodated by the seat belt restraints provided in the Vehicle and must ensure that each passenger in the Vehicle appropriately uses the seat belt restraint;

(c) not be under the influence of alcohol, drugs or have a blood alcohol or drug content that exceeds the legal limit in the State or Territory in which the Vehicle is driven;

(d) not use the Vehicle when it is damaged or unsafe;

(e) not smoke within the Vehicle or allow any other person to smoke within the Vehicle at any time;

8. The user will operate the hire vehicle only within the Sunshine Coast and Brisbane area or within a 180km radius

9. Any vehicle malfunction will be reported immediately to Just Autos.

10. Loan cars are intended for "Short term" use only and will not be used as a "long term" solution if a vehicle is to be held by Just Autos for a longer than intended period.

11. It is under Just Autos discretion to refuse the use of a Loan car

12. All loan cars are to be returned in a clean & tidy manner, if tolls have been incurred, they will need to be paid prior to returning vehicle, If tolls have not been paid prior to returning vehicle they will incur an administration fee to prepare an invoice & retrieve payment

13. All vehicle are to remain full of fuel, If vehicles are returned without filling the tank a cost of \$3.95 per/L will be invoiced and payment will be retrieved

14. Upon return of Just Autos hire car, the vehicle will be inspected by a representative of Just Autos to check on condition of vehicle when dropped off. If the vehicle is returned in an untidy manner and vehicle is not full of fuel a \$100 admin fee + Fuel at the pre-defined flat rate will be charged out on your final invoice at Just Autos **Agreement**

In respect to the above hire car agreement, I agree to the terms and conditions as stated above and will ensure I reimburse any fuel used when returning the vehicle.
